- 6. Only the prescribed form (Application to Participate in Public Bidding) shall be accepted as a formal bid.

- 1. Prospective bidders are enjoined to inspect the above-listed vehicles before submitting their bids. - 4. In the event that the public bidding is declared a failure wherein no interested bidder submitted an offer to bid, the property will be made available for negotiated sale offer immediately subject to the payment of the 10% of the offered price and the existing Bank policies.
