**PRE-BIDDING CONFERENCE:**

- The Pre-bid Conference will be held on **April 10, 2024**, via video conference (MS Teams application).
- Details and invitation link will be sent via email to all registered bidders.
- All registered bidders are encouraged to attend the pre-bidding conference to discuss the documentary requirements in the uploading of bids.

**BIDDING REQUIREMENTS:**

- The prospective bidder shall submit his/her electronic bid by uploading the same in the LBP-SFTP (Guide in Accessing LBP Secure File Transfer Facility will be sent via email after successful registration and will be discussed during the Pre-bid Conference).
- Submission/uploading of bids will be from **April 11-24, 2024**.
- Only bids that are successfully uploaded on or before the deadline shall be accepted. Failure to upload the bid until **April 24, 2024 at 5:00 p.m.** shall disqualify the interested bidder from joining the public bidding.
- The bid bond shall be in the form of Cashier's or Manager's Check issued by any commercial bank payable to Land Bank of the Philippines or signed Authority for Fund Transfer from LBP Account.
- Opening of Bids will be on **April 26, 2024 at 9:30 a.m.** thru videoconference (Microsoft Teams Application).
- Only the prescribed form (Application to Participate in Public Bidding) shall be accepted as a formal bid.

**IMPORTANT REMINDERS:**

1. Prospective bidders are enjoined to inspect the above-listed vehicles before submitting their bids. For the sale of vehicles where Vendor disclosure/s are needed, a Disclosure Statement will be issued by the Secretariat upon request by an interested bidder and will be given to all participating bidders on the scheduled public bidding. The sale of the vehicles shall be on "**AS-IS-WHERE-IS**" basis with regard on the physical and legal state of the subject vehicles and the corresponding ORs/CRs.
2. In the event that the highest bidder is the former owner, his/her bid price shall be subject to additional charges such as but not limited to outstanding loan obligation, among others, if there is any, before he/she will be declared as the winning bidder.
3. In the event that the public bidding is declared a failure wherein no interested bidder submitted an offer to bid, the property will be made available for negotiated sale offer immediately subject to the payment of the 10% of the offered price and the existing Bank policies.
4. If for any reason, the above-mentioned date is declared a non-working holiday, the Bank shall publish a notice to the public announcing the date, time, and venue of the public bidding.
