INVESTMENT OBJECTIVE AND STRATEGY

To generate capital growth while maintaining steady stream of income through a combination of diversified investments in peso-denominated listed equities and tradable fixed income securities. The fund is suitable for investors who are willing to take extra risk in order to avail of the higher investment returns offered by the equities and debt markets.

CLIENT SUITABILITY

A *client profiling process* shall be performed prior to participating in the Fund to guide prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The LANDBANK Growth Fund is classified as a Balanced Fund suitable only for investors who:

- Have an Aggressive risk profile
- Can accept the risk that the principal investment can be lost in whole or in part
- With an investment horizon of 5 to 7 years.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Credit Risk/Default Risk. The risk of losses due to a borrower's failure to pay principal and/or interest in a timely manner on instruments such as bonds, loans, or other forms of security which the borrower issued.

Reinvestment Risks. The risk associated with the possibility of having lower returns or earnings when maturing funds or the interest earnings of funds are reinvested.

Interest Rate Risk. This is the possibility for an investor to experience losses due to changes in interest rates.

- The Fund implements a risk management policy that applies the principles of Value-at-Risk (VAR) and Modified Duration. VaR is defined as a statistical estimate of the amount of loss that an "open" risk position is unlikely to exceed during a given time period with a given level of confidence. Modified Duration is a means to measure the change in the value of a security in response to a change in interest rates. The formula is used to determine the effect that a 1% change in interest rates will have on the price of the bond.
- The Fund's investment outlets have been subject to proper screening and evaluation in accordance with LANDBANK – TBG's accreditation process and minimum regulatory requirements.
- To maintain a balance in debt and equity, the Fund will correspondingly invest no more than 60% in equity securities traded in the PSE, including common stocks and preferred stocks of any market capitalization.

REDEMPTION CONDITIONS

Surrender of the Confirmation of Participation; subject to penalty if redeemed before the minimum holding period. For Partial Redemption, remaining balance should not be less than minimum investment.

ONE YEAR FUND PERFORMANCE

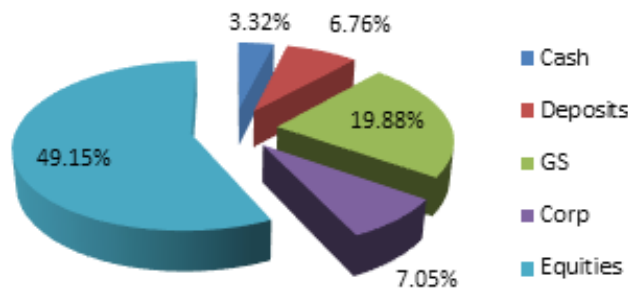

RELATED PARTY TRANSACTIONS

The Fund has deposits with LANDBANK amounting to P7,819,898.16, which is within the limit approved by the Board of Directors. Likewise, related parties transactions are conducted on an arm's length basis.

FUND MANAGER'S REPORT

The equities market saw some very steep losses as hot money registered massive net outflows in April and May to the tune of \$1.6 billion. This reflected the erosion in corporate earnings, with over 85% of index firms' bottom-lines contracting. The downwardly revised economic prospects of the country also fed the pessimism. And because the government's fiscal stimulus program is very conservative, there isn't much to look forward to in the direction of jumpstarting the economy. Equities will continue to struggle. As for fixed-income, the bull run has been on-going even before the pandemic hit. This was just reinforced when the lockdowns were put in place, essentially shutting down the economy. Although the stimulus measures unleashed by major economies are reaping desired benefits, easing down lockdowns are resulting in spikes in new infections. The dire threat of second waves of the virus will keep the uncertainty level high. This, in turn, will keep demand for safe haven high and exert downward pressure on interest rates. Still, it would be prudent to stay short. It would pay to be extra vigilant as the emergence of an effective vaccine could very well be an inflection point.

VIEW STRATEGY

For the equity component, it would be prudent to average down costs on market weakness. For fixed-income, positioning at this point should only be in short tenors, given that rates are at an all-time low. Monitoring developments and acting appropriately regarding the development of vaccines cannot be overstated as this could reverse the economic cycle.
