INVESTMENT OBJECTIVE AND STRATEGY

The LANDBANK Money Market Fund aims to provide investors high liquidity and minimal risk but with decent returns on their capital from short-term fixed-income investments.

CLIENT SUITABILITY

- Have a Conservative Risk Profile
- With an Investment Horizon of < 1 year

KEY RISKS AND RISK MANAGEMENT

Credit Risk/Default Risk. 



FUND MANAGER'S REPORT

With the Covid situation getting progressively worse throughout the year, the BSP did everything in its power to prop up the economy by loosening monetary policy as much as possible. By the end of the year, the key policy rate stood at 2.0% -- an all-time low. This, in turn, affected deposit rates which similarly dropped to all-time lows. From the look of thing this low interest rate regime will last at least trough the first half of 2021.
