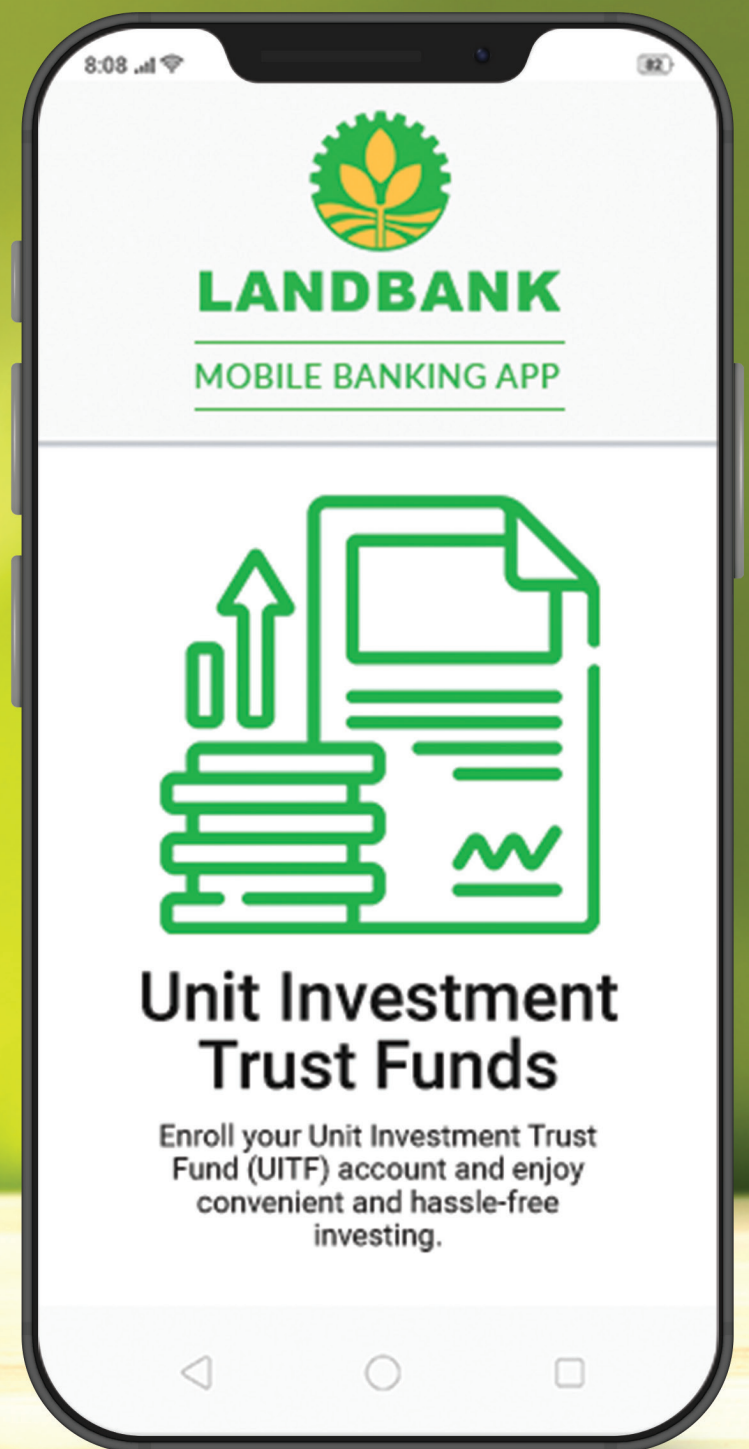

# LANDBANK i-Invest

Unit Investment Trust Funds are now accessible via  
the LANDBANK Mobile Banking Application

The i-Invest is the online investment platform for LANDBANK UITFs which is accessible through the LANDBANK Mobile Banking App. It allows you to view the details of your existing UITF portfolio and add to your investment.

## Features:

- **Enrollment of Existing UITF account\***

Register your existing peso and dollar denominated UITF accounts in the MBA.

- **Viewing of UITF Portfolio**

View the latest investment value of your UITF portfolio, pending transactions, and transaction history.

- **Subscription to peso-denominated UITFs online**

Top-up your existing investment or initially invest in funds prescribed for your risk profile.

- ▶ ***Minimum Initial Investment:***  
***P5,000.00***

- ▶ ***Minimum Additional Investment:***  
***P1,000.00***

*\*Your mobile number registered with the LANDBANK-Trust Banking Group must be the same as your mobile number used in iAccess and MBA OTP transactions.*

# How to enroll your existing UITF Account in the MBA:

1. Log-in to your **LANDBANK MBA**. Click **“More”** then select **“Manage My Accounts”** > **“Enroll Additional Own Account”** > **“Investment”**.
2. Enter your **UITF Trust Account Number (TAN)**, including special characters (e.g. dashes **“-”**), and click **“Submit”**.
3. A **One-Time PIN (OTP)** will be sent to your registered mobile number. Enter the OTP and click **“Next”** to proceed with the enrollment.
4. Review the transaction details and be sure to read and understand the **Terms and Conditions**. Signify your agreement by clicking the checkbox. Press **“Confirm”** to continue with enrollment.
