- 3.h Brochures or any other document indicating the complete specifications of the offered laptop computer
- 3.i. Certification issued by bidder's manufacturer stating that the bidder is one of its authorized dealer/reseller/service provider of the offered laptop computer
- 3.j List of service and local parts centers in Metro Manila, Cebu and Davao with complete addresses, contact persons and contact numbers
- 3.k Valid joint venture agreement (JVA), in case the joint venture is already in existence.
