- Sections VI (Specifications), VIII (Bill of Quantities) and Checklist of the Bidding Documents (Items 8, 9 & 11 of the Technical Component and Item 2 of the Financial Component) have been revised. Please see attached revised specific sections of the Bidding Documents.
- The Bill of Quantities (BOQ) has been revised. Bidders may obtain a soft copy of the BOQ for the above project from the Procurement Department.




