In compliance with the requirements of the covering policies, rules and regulations of the Department of Environment and Natural Resources (DENR) and the Environmental Management Bureau (EMB), the supplier shall always maintain cleanliness at all times. It shall also be responsible for the collection and its proper disposal outside of the Bank premises of all waste materials resulting from any activity related to the implementation of the project.
- e. Be bounded by and shall strictly observe the Bank's existing rules and regulations with regard to the standard security and safety policies, systems, and procedures while in the premises.
