




1.	If the ABC could be aggregated.	The prospective bidder may opt to use aggregate contract as indicated in the Bid Data Sheet ITB Clause 5.3, page 21 of the bidding documents.
2.	Can we submit the Mayor's permit from 2023 while we wait for the new mayor's permit for 2024 because the company is in the process of renewing the business permit for 2024?	<p>Bidder must comply with the requirements under Section 23.1.a).ii) of the Revised Implementing Rules and Regulations of Republic Act 9184 (as of October 15, 2023), to wit:</p> <p>"ii) Mayor's/Business permit issued by the city or municipality where the principal place of business of the prospective bidder is located, or the equivalent document for Exclusive Economic Zones or Areas.</p> <p>A recently expired Mayor's/Business permit together with the official receipt as proof that the prospective bidder has applied for renewal within the period prescribed by the concerned local government unit, shall be accepted by the PhilGEPs for the purpose of updating the PhilGEPs Certificate of Registration and Membership in accordance with Section 8.5.2 of this IRR."</p> <p>As such, the prospective bidder must coordinate directly with PhilGEPs to submit the above mentioned requirements for updating of their PhilGEPs Certificate of Registration in accordance with Section 8.5.2 of the IRR of RA 9184. The failure by the prospective bidder to update its PhilGEPs Certificate of Registration with the current and updated Class "A" eligibility documents shall result in the automatic suspension of the validity of its Certificate until such time that all of the expired Class "A" eligibility documents has been updated.</p>
