Modifications, amendments and/or clarifications:

- 2. The bidders are reminded that the deadline of Bid Submission and Opening is on 17 January 2025 at 10:00 AM. Late bids shall not be accepted.
- The bidders are encouraged to use the Bid Securing Declaration as Bid Security.
- 4. The prospective bidders are reminded that <u>only</u> the <u>current/updated Certificate of PhilGEPs Registration (Platinum Membership)</u> shall be accepted during the opening of bids. Expired Certificate or any of the Eligibility Documents listed in Annex "A" shall be a ground for failure of the bidder pursuant to the provisions of the 2016 Revised Implementing Rules and Regulations (RIRR) of RA 9184.

Valid and current Certificate of PhilGEPs Registration (Platinum Membership), in three (3) pages, including Annex "A" or the List of Class "A" Eligibility Documents **required** to be uploaded and maintained current and updated in PhilGEPs in accordance with **Section 8.5.2.** of the IRR of RA 9184.

Sections 23.1(a)(ii) and 24.1(a)(ii) of the 2016 RIRR of RA No. 9184 provides that in case the latest/updated Mayor's Permit is still not available, the prospective bidder must submit their recently expired Mayor's Permit together with the official receipt (OR) to the PhilGEPs as proof that the prospective bidder has applied for renewal within the prescribed period by the concerned local government unit for the purpose of updating the PhilGEPs Certificate of Registration (Platinum Membership). The prospective bidder should then secure/obtain from the PhilGEPs its current/updated Certificate of PhilGEPs Registration (Platinum Membership) in three (3) pages, including Annex "A" or the List of Class "A" Eligibility Documents.

Vendors must be feasible with the installation of the required MPLS leased lines for all the Offsite ATMs listed in a Lot indicated in 2.1 to qualify in the bidding for the said Lot.	May we request the possibility of relaxing the 'all or nothing' bid condition. Specifically, we are seeking flexibility to focus on the sites that can be served, allowing us to proceed with those locations where feasible.	We stick with the Condition 2.2b of the Terms of Reference wherein the Vendors are required to be feasible with the MPLS leased line installation (at least 2 Mbps) in all sites listed in a Lot to qualify for bidding.
	3. Technical Requirements 3.6 Physical/last-mile connectivity to the remote facility should be provided by means of fiber optic cable, including the installation of fiber cable from Vendor facility (Node) up to the remote site (booth/server rack/room). Cable conduit shall be provided by the Bank if needed.	For remote sites, may we request the possibility of using a wireless solution as an acceptable alternative for sites that are not feasible with fixed solution?	We cannot accept wireless solution for the last-mile connectivity. Again, we are sticking with the ones specified in the Technical Requirements particularly Section 3.6 – remote facility should be provided by means of fiber optic cable.
