## LANDBANK continues to support tax collection, payments

LANDBANK continues to support the Bureau of Internal Revenue (BIR) in tax collection and ensures taxpayers can conveniently pay their dues.

With digitalization, filing and paying taxes were made more efficient and convenient. Companies and individuals enrolled in the BIR's Electronic Filing and Payment System (eFPS) can pay their tax dues through the Electronic Tax Payment System (eTPS) powered by LANDBANK.

Individuals and other businesses not eligible to pay via eTPS can electronically pay their taxes through the LANDBANK Link.BizPortal. To do this, they need to go to the website and choose the "BUREAU OF INTERNAL REVENUE" among the list of merchants, choose the form type and tax type they are paying for, and proceed with the payment transaction.

Apart from the BIR, taxpayers can also pay for their taxes coursed through their local government units such as real property taxes and business taxes using the Link.BizPortal.

To accommodate and assist taxpayers with their electronic payments, LANDBANK partnered with the BIR and opened temporary hubs in select Revenue District Offices (RDOs) until April 17, where customers accessed LANDBANK's digital payment channels. There were Branch personnel assigned at the RDOs to assist and guide customers on how to use these digital channels.

These alternative payment channels help make paying taxes to the National Government easier and more convenient for taxpayers.

Meanwhile, select LANDBANK Branches were opened on April 1, 8, and 15, Saturdays, to accommodate individuals who prefer to pay taxes over the counter. At the same time, select LANDBANK Branches also extended their banking hours until 5:00 PM during weekdays from April 1 to 17, 2023 to accept tax payments.

As the tax collection arm of the National Government, the BIR relies on LANDBANK as a steadfast partner. Through its digital and traditional channels, the Bank contributes to improving the efficiencies in the collection and payment of taxes.

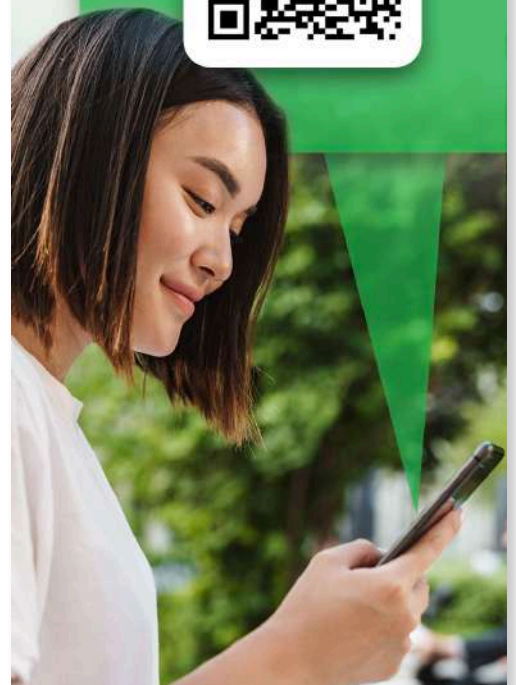
