- If at least one (1) bid meets the minimum price and requirements, the bidder will be selected.
- If no valid bids are received, the PF Board of Trustees may offer the vehicle for Negotiated Sale.
- If the scheduled bidding date is a non-working holiday, it will be reschedule accordingly.
