1. Promo Period*

The promo originally scheduled from **February 1, 2025 to July 31, 2025** has been extended until **December 31, 2025**, as approved by DTI-FTEB.

2. Who Can Join

Open to all **new and existing private individual and institutional** LANDBANK deposit account holders, except:

- Employees of LANDBANK
- Members of the LANDBANK Board of Directors
- Relatives of the above up to the second degree of consanguinity or affinity

3. Eligible Products

The following accounts qualify for earning e-raffle entries:
