In connection with the SEC 17-C disclosure dated 04 October 2021 on the Monthly List of Subsidiaries, we would like to apprise you that:

1. On 24 September 2021, LANDBANK executed the Deed of Absolute Sale with Philippine Deposit Insurance Commission (PDIC) for the acquisition of its Special Preferred Shares (SPS) which comprises 88.91% of UCPB's outstanding capital stock.
2. To date, we are awaiting the release of the Certificate Authorizing Registration for the transfer of the ownership of the SPS in the name of LBP.
3. The transfer of the ownership of the SPS in the name of LBP will make UCPB an LBP subsidiary.


