INVESTMENT OBJECTIVE AND STRATEGY

As a Dollar-denominated Bond Fund, the LANDBANK Global \$ Fund aims to provide relatively higher income through investments in Dollar-denominated fixed-income securities issued by the National Government and by local companies. Ideal for moderate investors who are willing to take on minimal risks for better returns.

CLIENT SUITABILITY

A *client profiling process* should be performed prior to participating in the Fund to guide prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The LANDBANK Global Dollar Fund is classified as a Bond Fund suitable only for investors who:

- Have a Moderate risk profile
- Can accept the risk that the principal investment can be lost in whole or in part when the NAVPU at the time of redemption is lower than the NAVPU at the time of participation.
- With an investment horizon of 3 to 5 years.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Credit Risk/Default Risk. The risk of losses due to a borrower's failure to pay principal and/or interest in a timely manner on instruments such as bonds, loans, or other forms of security which the borrower issued.

Reinvestment Risks. The risk associated with the possibility of having lower returns or earnings when maturing funds or the interest earnings of funds are reinvested.

Interest Rate Risk. This is the possibility for an investor to experience losses due to changes in interest rates.

- The Fund implements a risk management policy that applies the principles of Value-at-Risk (VAR) and Modified Duration. VaR is defined as a statistical estimate of the amount of loss that an "open" risk position is unlikely to exceed during a given time period with a given level of confidence. Modified Duration is a means to measure the change in the value of a security in response to a change in interest rates. The formula is used to determine the effect that a 1% change in interest rates will have on the price of the bond.
- The Fund's investment outlets have been subject to proper screening and evaluation in accordance with LANDBANK – TBG's accreditation process and minimum regulatory requirements.

REDEMPTION CONDITIONS

Surrender of the Confirmation of Participation; subject to penalty if redeemed before the minimum holding period. For Partial Redemption, remaining balance should not be less than minimum investment.

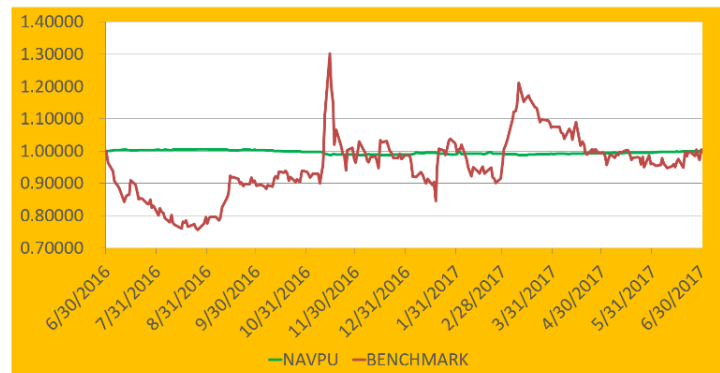

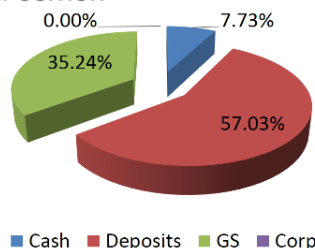
¹Volatility measures the fluctuations in the yield. A higher value means more dispersion from the Fund's average yield.

RELATED PARTY TRANSACTIONS

The Fund has deposits with LANDBANK amounting to \$93,597.73, which is within the limit approved by the Board of Directors. Likewise, related parties transactions are conducted on an arm's length basis.

FUND MANAGER'S REPORT

The month ended with St. Louis Fed President James Bullard saying that a reduction of their balance sheet is a priority and should start soon. Shrinking the Fed's balance sheet can have a similar effect to tightening interest rates because it eliminates a big buyer of government bonds, which can push yields higher.

Mixed data came out of the US with the 1st Quarter GDP numbers being stronger than expected at 1.4% versus 1.20% market consensus. Jobless claims printed worse at 244,000 against 240,000 market forecast wherein the UST10yr closed at 2.27% up by 4bps.

HY Sovs continued to track UST movements with wide spreads and mixed flows from both dealers and retail accounts. INDON prices were unchanged to 0.375 lower with INDON46 trading at 117.875-118.50. Benchmark ROP42 also ended the month unchanged trading at 100.25-100.75.

VIEW STRATEGY

With the recent FED interest rate hike and a hawkish tone to implement more rate hikes up to year-end of 2017, the Fund strategy is to maintain current positions weighted in short-term deposits placement, to protect the Fund from further volatility brought about by rate hike and global market issues.
