INVESTMENT OBJECTIVE AND STRATEGY

The LANDBANK Money Market Fund aims to provide investors high liquidity and minimal risk but with decent returns on their capital, from special savings deposit accounts and other interest bearing deposits.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The LANDBANK Money Market Fund is suitable only for investors who:

- Have a Conservative Risk Profile
- With an Investment Horizon of < 1 year

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Credit Risk/Default Risk. The possibility for an investor to experience losses due to a borrower's failure to pay principal and/or interest in a timely manner on instruments such as bonds, loans, or other forms of security which the borrower issued.

REDEMPTION CONDITIONS

Surrender of the Confirmation of Participation; subject to penalty if redeemed before the minimum holding period. For Partial Redemption, remaining balance should not be less than minimum investment.

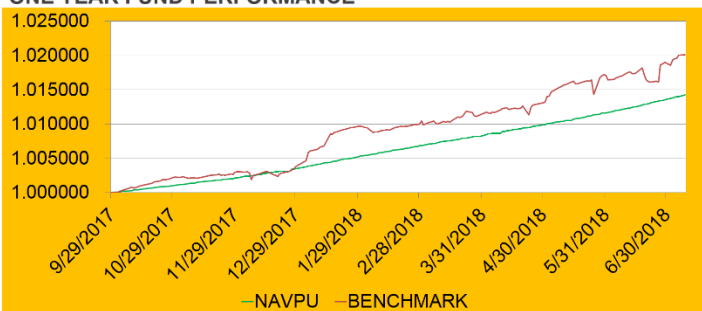

ONE YEAR FUND PERFORMANCE



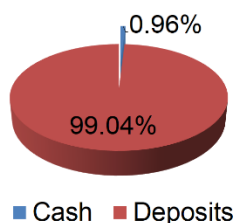

RELATED PARTY TRANSACTIONS

The Fund has deposits with LANDBANK amounting to PhP2,606,319.25 which is within the limit approved by the Board of Directors. Likewise, all related parties transactions are conducted on an arm's length basis.

FUND MANAGER'S REPORT

The Federal Reserve followed its deliberate plan raising key policy rates to 2.0 – 2.25% (25bps) in the September FOMC meeting. The move was consistent with market expectations as the backdrop of U.S. economic growth remains strong. While job gains, household spending, and business investment fuel economic activity, risks of capacity constraints and inflation pave the way for another 25 bps hike before the year ends. In the longer policy horizon, forecasts remain unchanged at a median policy rate of 3.4% in 2020.

Locally, the BSP has raised key rates to 4.0-4.5% in a successive tightening streak to curb persistent and broadening price pressures. These pressures driven by supply side factors continue to pose threats to the inflation outlook. In effect, baseline forecasts have shifted higher for both 2018 and 2019. Policy-wise, the BSP executed a total of 150 bps rate hike since May but an extensive assessment placed emphasis on non-monetary policy measures to anchor inflation expectations.

VIEW STRATEGY

The Fund investment is in banks high yielding deposits maximizing available tenors with best yields.
