The LANDBANK Money Market Plus Fund aims to achieve liquidity and potential higher income from short-term fixed income investments.

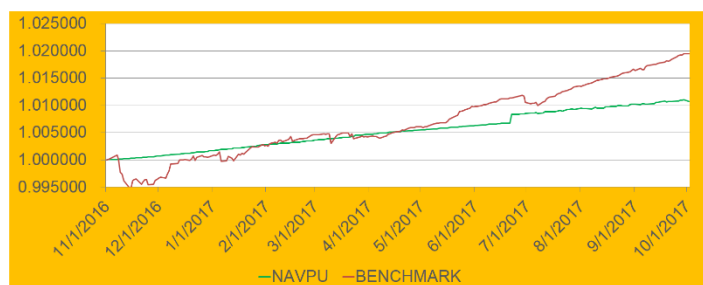

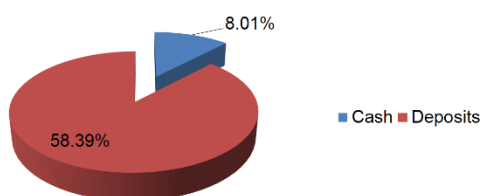

### RELATED PARTY TRANSACTIONS

The Fund has deposits with LANDBANK amounting to Php445,791.77 which is within the limit approved by the Board of Directors. Likewise, all related parties transactions are conducted on an arm's length basis.

### FUND MANAGER'S REPORT

Key policy rates were unaltered for the third quarter period as the BSP perceived a manageable inflation outlook throughout the year. Overnight lending rate remained at 3.5%; overnight reverse repurchase rate at 3.0%; and overnight deposit rate at 2.5%. Also, reserve requirement volumes were unchanged.

Inflation trended higher for the third quarter as July CPI data was recorded at 3.1%, a rate maintained in August, then skipped to 3.4% in September. This yielded a year-to-date average of 3.1% as of quarter-end; within the target range of BSP (2.0 - 4.0%) for the entire 2017. The acceleration of prices was attributed to food price increases. Moreover, risks continue to project upwards as pressures may spur from the current administration's proposed tax reform plan. But despite faster upturns, BSP still sees no pressure for policy adjustments given a manageable inflation horizon.

Local fixed income yields trended downwards into August then drove up after the Fed released a statement in September's policy meeting concerning the balance sheet normalization coupled with prospects of another rate hike by year-end. The 10-year benchmark bond FXTN 10-60 traded at 4.397% level by end-September, while 10-year US treasury ended at 2.330% level.

The BSP's Term deposit facility, particularly the 28-day tenor, volume offered was reduced from 140 Bn to 100 Bn due to a continued decline in demand.

### VIEW STRATEGY

Fund distribution is in banks high yielding deposit products and will slowly increase investment in short-term government securities which contribute growth in Fund returns with less volatility.
